**Thursday, April 7, 2011**

**Committee Business**

Chair Custer called the meeting to order at 7:59 A.M.

**Agenda Review**

Approval of January 11-13, 2011 minutes

MOTION: Rod moved to adopt the January 11-13, 2011 minutes. Pat Seconded. The motion passed unanimously.

Kyleen Stone, OPRD Assistant Director, updated the committee on the legislative process, specifically HB 2329 that is scheduled for public hearing and work session on Monday, April 11, 2011. The bill creates a Class IV classification that includes side by sides and adds some technical changes to include a Class IV representative for the ATV subcommittee, an ADA representative, and a representative from the Fish and Wildlife Department. Additionally it requires a driver's license if the driver is 16 or older. Criteria will need to be developed for those under 16. The bill makes changes to the weight limit for Class III from 800-1200 pounds and changes to the definition of low tire pressure. Additional changes can occur in the future if and when needed such as: manufacturer on committee (official member or just invite). Rod Roberts has been invited to testify before the legislative committee, as are all members.

Nathan: In the future we may need to visit the load bearing limit.

**Budget Discussion**

Kyleen discussed the ATV program budget and her concern about sweeping the ending balances that occurred last session. Tim Wood, OPRD Agency Director testified before the legislature noting his concerns regarding the allocation of funds; they promised that would not occur this session. There were no major changes in the ATV program within the OPRD budget.

MOTION: The ATV Grant Subcommittee supports the proposed staff and industry recommendations for changes to the class IV definition regarding the gross vehicle weight, replacing low pressure with Pneumatic tires.

Pat moved, Rod seconded. The motion passed unanimously.

Discussion on available funds for tomorrow's grant presentation and having more requests than money. Ron suggested that after scoring is completed to determine what does and does not get funded.

Wayne discussed requesting additional limitations from the legislature, which is not doable at this time. However, if a true emergency comes up then we can go to the Emergency Board.

Tim: We might want to increase our request during the 2013-15 biennium.

Ian: Talks about opening up trail systems as part of the federal travel management process.
